COOKIE INFORMATION NOTICE

1 PURPOSE

When you access our website www.yilport.com YIlport Holding A.Ş. ("YIlport Holding") obtains some cookies. This information notice has been prepared to provide you with a better understanding of the cookies obtained and used, to inform you about cookies, to inform you how and for what purpose cookies are obtained and to enable you to manage the cookies used.

2 WHAT ARE COOKIES?

Cookies are text files containing small amounts of information that are downloaded to your computer or mobile device when you visit a website and allow a site to recognize your device. The information collected through cookies is generally used to improve your experience on the website, increase the performance and efficiency of the website, determine user habits, for security purposes, and for advertising/marketing and similar purposes. These cookies allow the collection of information such as browser type, time spent on our website, pages visited, language preferences and other anonymous traffic data.

Cookies may remain on your devices for different periods of time, which are referred to as persistent and session cookies. Session cookies expire when you close your browser. Persistent cookies, on the other hand, remain after you close your browser until you delete them, and can then be used by your browser when you visit the website again (for example, to remember your login information).

Cookies may be placed by Yılport Holding (**first-party cookies**) or by third-party service providers (**third-party cookies**). Whether the cookie is first-party or third-party depends on the cookie placed by the website or domain.

The following types of cookies are used on our website.

2.1 STRICTLY NECESSARY COOKIES

These cookies are cookies that must be saved in order for our website to work in accordance with its intended purposes. These cookies are used compulsorily in order to fulfill the preferences you have requested (such as logging in, form filling, remembering privacy preferences).

These cookies cannot be disabled or rejected without affecting the proper functioning and functionality of our website. Without these cookies, you will not be able to navigate our website or use the basic functions we target.

2.2 PERFORMANCE – ANALYTICS COOKIES

These cookies are cookies that allow statistical measurement in order to analyze your behavior on our website. These cookies are frequently used for the improvement of our website, including the measurement of the impact of advertisements on the people concerned. They are used by website owners to estimate the number of unique visitors, to identify the most important search engine keywords that lead to a web page, or to track website navigation.

You can always change your preferences for the use of these cookies.

2.3 ADVERTISING – MARKETING COOKIES

These cookies track your online activity to figure out what are your personal interests, so websites can show you personalized advertisements that are more relevant to you.

You can access information about the cookies used on our website from the "Cookie Settings" panel.

3 HOW CAN YOU MANAGE YOUR COOKIE PREFERENCES?

Strictly necessary cookies used on our website ensure the proper functioning of our website. For this reason, strictly necessary cookies cannot be disabled or rejected.

However, you can disable the use of cookies other than strictly necessary cookies by using the cookie management panel that appears when you first visit our website. You may also consent to the use of cookies by clicking on the *cookie preferences tab* on our website at any time during your visit, our you may choose to refuse or block all or certain types of cookies that are placed on our website by withdrawing your consent. Check or uncheck the buttons on the Cookie Management Panel according to your preference and click the "Save Settings" button. You will need to refresh the page for your settings to take effect.

In addition, most browsers automatically accept cookies. Therefore, if you do not want cookies to be used, you can set your cookie preferences for our website and/or any third-party website by changing your browser settings. You may;

- Change your browser settings to delete all cookies. However, if you delete cookies, you might get signed out of sites that remember you and your saved preferences could be deleted.
- Block all cookies. If you block cookies, the websites you visit may not function as intended.
- Allow the use of cookies.
- Block third-party cookies. If you block third-party cookies, all third-party cookies from other sites
 are blocked unless the site is allowed on your exceptions list. However, even if you block thirdparty cookies by default, you can still allow their use for a specific site.
- Delete all cookies when you close your browser.
- You can also use your browser's "incognito" session feature to browse without saving your browsing history or storing data such as cookies.
- You can use add-ons and plugins that extend browser functionality.

4 YOUR PERSONAL DATA PROCESSED THROUGH COOKIES, PURPOSE OF USE AND TRANSFER

Cookies are personal data to the extent that they make your identity specific or identifiable. We attach great importance to the lawful processing and security of your personal data such as IP address, website usage information, browser selection, location and device information obtained during your use of our website through cookies within the framework of the Law on Protection of Personal Data No. 6698 ("KVKK"), the European Union General Data Protection Regulation ("GDPR") and the relevant secondary legislation. We process the personal data we receive by automated means for the purposes of maintaining the basic functions of our website, facilitating navigation and increasing its efficiency/performance.

Strictly necessary cookies are processed **without your explicit consent** based on the legal grounds that "processing of personal data belonging to the parties to a contract is necessary, provided that it is directly related to the establishment or performance of a contract" and "data processing is mandatory for the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the data subject".

On the other hand, performance - analytical cookies are processed for the purposes of analyzing your behavior on our website only *in the presence of your explicit consent*. Similarly, advertising-marketing cookies are processed only **with your explicit consent** in order to create personalized profile according to your interests and to show you relevant advertisements.

If you give your explicit consent to the processing of performance - analytical cookies, your personal data will be stored on Google Analytics' servers located abroad. You can find detailed information on how your data is used by Google Analytics here.

Your personal data will be kept only for the period prescribed in the relevant legislation or for the period necessary for the purposes for which they are processed and in any case within the periods indicated in the table above. At the end of the period or when the reasons for processing the data cease to apply, your personal data will be erased, destroyed or made anonymous.

5 YOUR RIGHTS AS DATA SUBJECT

If you access our website from Türkiye, you have the following rights as per the Article 11 of the KVKK regarding cookies containing personal data:

- To learn whether your personal data is processed or not;
- To request information if your personal data has been processed;
- To learn the purpose of processing personal data and whether they are used in accordance with their purpose;
- To know the third parties to whom your personal data is transferred domestically or abroad;
- To request rectification of personal data in case of incomplete or incorrect processing of personal data and request erasure or destruction of personal data within the framework of Article 7 of KVKK;

- To request notification of the rectification and destruction procedures to third parties to whom personal data has been transferred;
- To object to the processing of personal data exclusively through automated systems in the event that a result to your detriment arises; and
- To request compensation for damages in case of damage due to unlawful processing of personal data.

If you access our website from European Union countries, you have the following rights as per the Section 3 of the GDPR regarding cookies containing personal data:

- To receive information about personal data processing activities;
- To access to your processed personal data and the processing activity;
- To request rectification of your personal data;
- To request erasure of your personal data (right to be forgotten);
- To request restriction of personal data processing activities;
- To request notification of the rectification or erasure of your personal data or restriction of processing to third parties to whom your personal data has been transferred;
- To request the transfer of your personal data to another data controller;
- To object; and
- Not be the subject to a decision based solely on automated processing, including profiling, which produces legal effects on you or similarly significantly affects you.
